CARS PROJECT UPDATE COMPLETED AND UPCOMING ACTIVITIES



- Completed a second round of testing in December 2020
- SOS User Acceptance Testing (UAT) starts next month (mid-February).
- Stakeholder engagement meetings continue and will expand to additional groups (Good Government February; the media May).
- Communications continue through website postings, updates to FAQs, periodic newsletters, and "Contact CARS" email.

CARS PROJECT UPDATE REVISED PHASED IMPLEMENTATION APPROACH



Plans are being finalized for a revised CAL-ACCESS phased implementation approach.

- ➤ Release I Implement February 28: Majority of functionality; internal and select externals will have access
- ➤ Release 2 April 30: Correspondence, Financial Transactions, API initial filings, E530 and more
- ➤ Release 3 June 30: Public to have access, and system certification by the Secretary

CARS PROJECT UPDATE BENEFITS OF THE NEW PHASED APPROACH



- Provides improved product delivery
- Enables SOS users to gain ability and assist external users at the time of external implementation
- Provides time for select external users (FPPC, FTB and SIG) to perform a system review and submit feedback
- Provides additional time for software vendors to test the API and become certified software vendors
- Minimize changes to team in lobbying registration period

CARS PROJECT UPDATE IMPORTANT DETAILS



- Testing will continue to utilize mock data.
- Data from the current system will be migrated to the New CAL-ACCESS prior to external implementation (June).
- The Lobbying Directory will be produced using the current system.
- FPPC and FTB users will have the same access as today.



EXTERNAL USER SYSTEM REVIEW

- System review of the New CAL-ACCESS will take place March through May 2021.
- Participants include FPPC, FTB, and members of the Stakeholder Input Group (SIG).
- Input will be used for the initial external implementation in June and for future releases.



CERTIFICATION OF THE NEW CAL-ACCESS

- New CAL-ACCESS system certification is targeted for the date of external implementation (June 2021).
- The New CAL-ACCESS becomes the "system of record" at the time of external implementation.
- The Certification Checklist created by PRD team includes criteria for certification.
- We are running a parallel activity for certification of software vendors.



NEW CAL-ACCESS TRAINING

- Plans are being finalized for SOS user training.
- SOS user training materials will be saved to a special SharePoint site for easy access (manuals, process diagrams, and quick reference guides).
- Select external users (FTB and FPPC) will receive a four-hour virtual classroom training session in May.
- External user instructional materials will be provided during training and will be available on the CAL-ACCESS website.
